Test Result:


17.3 Wear and Fatigue Test for All Hinged Door (Mod.) Pass
 --- Attach a specific load (of 5 kgw) to center of the door of storage which is equally distributed on both sides of the door.
 --- Cycle the door from a position 10° from fully closed to a position from fully open and return, not exceed a maximum swing angle 90°
 --- Cycle the door 160,000 times. (Actual test: 8 c/min.; Door size: 321×382 mm)
 Requirement: There shall be no loss of serviceability.

Remark: The tested storage was provided by the applicant.

Finding: No visual structure or function failure was found.

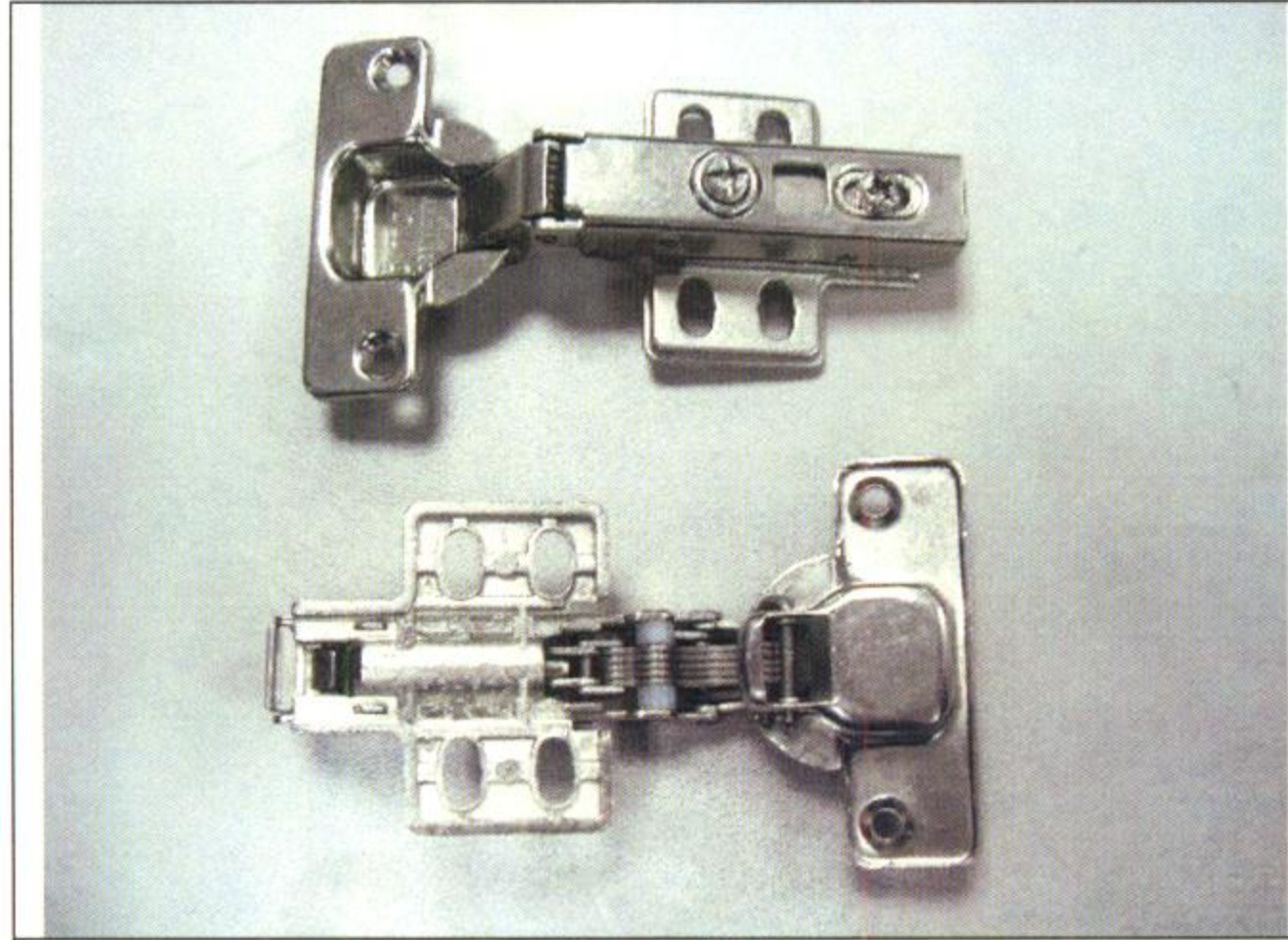
